During the operation of the single account center, external information plays an important role. Accounting theory is the basis for the formation of this external management information. MR Mathews and MX Perera stated that "Accounting today is characterized by the existence of theories that are not always compatible with each other, are vague or incomplete" [4:93].

Payment through a single payment receipt is made in the following order:

- > payments are transferred to the account number of the single settlement center in the bank. Often, this second bank is reflected in the settlement account, all transactions of which are related to the acceptance of payments by the owners of the premises, that is, it is separated from the rest of the financial and economic activities of the single settlement center;
- the electronic register of payments and notices from all payment points such as banks, post office branches, payment terms is sorted by the settlement points where the accounts were made;
- > the daily fee is determined at the calculation point in the payment registers for each housing owners' association and management organization;
- > a payment order is issued to each housing owners' association and management organization for the amount of the fee to be paid per day;
- based on the amount of fees for each individual account, the payment to the service providers specified in one check is calculated;
- the single settlement center sends settlement information on daily receipts to housing owners' associations and management organizations;
- > at the request of housing owners' associations and managing organizations, transfers the requested amount of funds to their bank account.

Although the process of establishing many new management organizations during the reform of housing and communal services is of a public nature, the outsourcing of settlement services through single settlement centers is a professional aspect of the management of new management organizations. is a way of mitigating the problems of acquiring skills. None other than single clearinghouses can perform this function effectively. Of course, at the same time, single clearinghouses must guarantee that the database of payments and payers will not be lost[5:12].

According to the legislation, the information about the owners of the premises is classified as confidential information, for these reasons, the companies and management organizations that serve the owners of the premises, that is, when the manager of the houses changes, all the information The database remains unchanged in a single clearinghouse, and it is convenient for users of the information, and control of the intended use and continuity of the information is ensured. Single clearing centers are important in providing a completely new level of transparency of the housing and communal services market, as single clearing centers must ensure the transparency of the settlement procedure.

The result of the study of scientific research literature shows that the position of fast information and knowledge in the national economy is growing very quickly, a new type of capital is emerging
